


- Head northeast on Laurelwood Rd toward Montague Expressway


- Turn right onto Mission College Boulevard




## From TiE Launchpad to Biltmore Hotel & Suites

**Local Gas Stations:** Nearby stations for refueling have been marked on the map above.

**Freeways and Departure:** The Biltmore Hotel has easy access to US Route 101 and the Montague/San Tomas Expressway.

#### US Route 101:

- Heading North will take you up the peninsula, through Palo Alto, San Mateo, and San Francisco.
   Continue to follow Highway 101 N and you will cross the Golden Gate Bridge to Mill Valley and San Rafael.
- Heading South on 101 will take you to interchanges with Interstate 880 and Interstate 680, on the way to South San Jose.

The Montague Expressway (Country Route G40):

- Heading East on the Montague Expressway (a right turn when exiting the Biltmore Hotel and Suites) is the most direct route to Interstate 880 and Interstate 680 either which can be followed North, through the Easy Bay area to Interstate 80 East and Sacramento..
- West, the Montague Expressway crosses Interstate 280, and joins Highway 17 which can be followed South to Santa Cruz.
