

### DATA POINTS - CLEARLY LAGGING INDICATORS

FEDERAL Employment (March 2020)

 Total nonfarm payroll employment fell by 701,000 in March 2020, and the unemployment rate rose by 0.9% to 4.4%.

This is the largest over-the-month increase in the unemployment rate since January 1975.

Employment in leisure and hospitality fell by 459,000 jobs. CALIFORNIA Employment (February 2020 - March data available 4/16)

Total nonfarm employment in California in February 2020 was 17.6 million with 2 million jobs being classified as being within the leisure and hospitality sector.

\$925,450 UI claims were filed for the week ending April 4 (last week's numbers available later today).

California UI claims for the week ending April 4, 2020, saw a 2,418% increase in UI claims processed by EDD over the same week a year earlier.

#### SUMMARY OF LAST MEETING

- A. 46 people participated in the April 2, 2020 roundtable.
- B. Main discussion points included:
  - New state disaster response actions
  - Rollout of the federal CARES Act funding in California
  - Identification of collaboration opportunities and program delivery gaps.
- C. Major take-away While the federal programs are starting to roll-out, small businesses remain confused about how to access and/or combine resources.

#### D. Findings and Follow-up From the Roundtable:

- There is a need to expand the administrative capacity of state-funded programs. While the business
  assistance centers are experiencing substantially more requests, their administrative capacity is not being
  increased.
- While online applications are useful for businesses with adequate digital capacity, this digital-only application environment does not always work for business owners from underserved groups who face tech challenges, from broadband speed to having to apply online using a phone.
- It is important to focus on the \$5 billion in federal CARES Act funds being awarded through CDBG.
- There is a substantial need to develop regional service and program delivery strategies that maximize new funding and more effectively reach underserved groups and geographic areas.

#### THE RECESSION — HISTORICAL DATA

National Numbers: February 2020 marks the end of the US's longest economic expansion of over 128 months without any significant declines in economic activity, according to the National Bureau of Economic Research. During this time period 22.2 million jobs were created across the country. This measurement includes multiple economic indicators, including jobs.

State Numbers: California job gains in February 2020 contributed to a record job expansion of 120 months with the state gaining 3.4 million jobs. According to EDD, from the period of February 2010 through February 2020, California job gains represented 15% of the national job gain of 22.8 million from February 2010 through February 2020.

\*8.7 million jobs were lost nationally during the Great Recession. California is reported to have lost 1.1 million jobs, with the highest statewide rate of unemployment of 12.9% in 2009.

OAssembly and Senate have begun budget hearings to review the impact of COVID-19 on the California Economy. More hearings are anticipated – but no details are known.

Senate has created both a research committee and a budget subcommittee to address
 COVID-19

OLegislature is currently scheduled to return on Monday, May 4, 2020.

• Policy and fiscal committee staff have been told to stand-by for information on a revised legislative calendar. This means committees are currently preparing bill analyses.
