The Assembly Committee on Jobs, Economic Development, and the Economy and the Assembly Budget Subcommittee 4 on State Administration are convening an informational hearing on the state's deployment of \$1.18 billion in federal funding that it anticipates receiving under the State Small Business Credit Initiative (SSBCI).

Research shows that the COVID-19 pandemic exacerbated income inequalities and disparities between certain population groups and areas of the state. These SSBCI funds represent a potentially transformational new resource which is capable of strengthening neighborhood-level economies, supporting independent wealth creation, and charting a more inclusive path forward. Building a more equitable and resilient economy will, however, require a continued commitment to address systemic barriers to entrepreneurship, as well as remaining open to the updating of programs and services to address current market needs.
