Data Points

- US unemployment claimed by first-time filers climbs to 6.6 million for the week ending March 28, 2020
- O Governor reported that EDD had received over 1.9 million unemployment claims since March 12, 2020
- O SBDCs in California have seen a 500% uptick in demand, based on anecdotal information
- Baseline: February 2020 unemployment rate in California was 3.9%.

New State Proposals – Announced April 2

- One-Year Deferment of Sales Tax: Governor announced a one-year moratorium on the payment of sales and use taxes up to \$50,000 per small business. Zero interest. Builds on prior state action that delayed the filing and payment of sales and use taxes to July 1, 2020.
 - The deferment effectively provides a bridge loan to give businesses time to apply for and receive federal loans, including SBA's Economic Injury Disaster Loan and the Paycheck Protection Plan.
 - Will be helpful to restaurants and small retail post-COVID-19 emergency.
- Funding for Microlending: Transfers \$50 million to the IBank Small Business Finance Center for the purpose of re-capitalizing the Small Business Loan Guarantee Program. Maximum loan of \$50,000. Eligible small businesses are those are not eligible for the federal programs.
- Launch of OnwardCA.org: New web platform to more effectively connect workers with available employment opportunities. Focus on, but not limited to, jobs within four areas – health care, agriculture, logistics, and groceries. More than 70,000 jobs currently listed.

Summary of April 2, 2020, Meeting

- 46 people participated in the April 2, 2020 roundtable. Thank you CAMEO for hosting.
- Main discussion points included: New State Disaster Response Actions; rollout of CARES Act funding in California; and identification of collaboration opportunities and program delivery gaps.
- Major take-aways: Next week will be a big week for small businesses. However, roll-out of the federal programs is still being pulled together.
- Follow-up:
 - There is a need to expand the administrative capacity of state-funded programs.
 - Online applications are useful for businesses with adequate digital capacity, but business owners from underserved groups may face tech challenges in a digital-only application environment.
 - CARES Act provides \$5 billion in new CDBG funds. The economic and business development stakeholders will be engaging on funding for non entitlement communities and the state's share of the \$1 billion in discretionary funding.
 - There is a need to develop regional service and program delivery strategies that maximize new funding and more effectively reach underserved groups and geographic areas.
